Ø All riders/horses participating at the CEI 2* 120 KM, CEI 1* 80 KM, CEN 80 KM, & CEN 40 KM must be registered with the FEI and therefore have an FEI ID.

See general Regulations, 23rd Edition Art. 113.3: "Any Athlete and/or any Horse who is not registered with the FEI shall be automatically disqualified."

All horses participating at the CEI 2* 120 KM, CEI 1* 80 KM, CEN 80 KM, & CEN 40 KM must be presented with an original FEI passport or an FEI approved National Passport with Recognition Card and with up to-date influenza vaccination record.

III NOVICE QUALIFICATION III: All NEW riders (Minimum age - 14 years) and all NEW horses (Minimum age - 5 years), must successfully complete 2 rides of distances between 40-79 km and 2 rides of between 80-90 km at speeds of 16 kph or under (not necessary as rider-horse combination). For the New Rider, he/she must be fulfil the above qualification within a period of not less than 6 months and within a maximum of 24 months. For the New Horse, these qualifications must be fulfilled within a period of not less than 12 Months and within a maximum of 24 months.

Ø During the First inspection on Friday, 25th November from 3:00pm to 4:30pm, the weight of the riders will be taken.

At the First Inspection please ensure that your horse is sufficiently warmed up before you bring it inside the vet gate. Any horse which will not permit examination or which is dangerous to the examiners shall be eliminated.

- ATTENTION!!! Please note that the Arrival gate, Vet In gate, Vet Out gate & Re-Inspection gate, is controlled by a Wireless Electronic Timing System. Therefore, it is mandatory for the horse to enter the gate so that status reports/current standings can be obtained from the computer personnel at the gate. The report can be collected by the Grooms or crew members upon arrival.
- Ø Riders must wear hard type riding helmets with chin strap and shoes with heels.
- Ø (Art.810) Horse with draw reins and French reins are forbidden. Whips and spurs are not permitted.
- Ø Giving water or assistance of any kind from inside a car is forbidden. No crewing inside the vet gate.
- Ø Not more than two persons and the rider will be permitted into the vet gate.
- Ø All horses removed from competition, voluntarily or otherwise and at any point within the event, must be presented for veterinary inspection within 30 minutes of removal. If removal occurs on course the horse must be inspected by a member of the veterinarian panel as soon as it is returned to the ride base and the horse's veterinary records updated accordingly.
- Ø Any horse retired after the start must be shown to an official Ride Veterinarian before it leaves the venue.
- Ø Bottles of water will be given to the riders before departure for each stage from the village/venue while presenting the departure paper to the Secretary.
- Ø Footwear without a heel only permitted when using caged stirrups or similar. Riders Must Complete the Ride Category within the below Time Limit
- Ø Time limit for CEI 2* 120 KM : 11 H 40 MIN
- Ø Time limit for CEI 1* 80 KM : 07 H 50 MIN
